# **Poultney Town Hall**

Jeff King called the meeting to order. Selectmen present included: Jeff King, Tom Coloutti, Frank Fressie, Terry Williams. Others present included Paul A. Donaldson, Town Manager, Neisja Crawford, Secretary / Bookkeeper, Sheriff Stephen Benard, Kathleen Guinness, Ryan Ihrke, and members of slate industry and towns people (see sign in sheet)

**Adoption of the Agenda:** Tom Coloutti made a motion to adopt the agenda. Terry Williams seconded the motion. Motion carried

<u>Approval of Minutes:</u> Terry Williams made a motion to approve the minutes of 10/23/17. Tom Coloutti seconded the motion. Motion carried

## **Public Comments and Concerns:**

- Jeff King: The Select Board received the Planning Commission's recommendation today, regarding the petition to Amend Bylaws, re: Section 417: Slate Mining, Section 418: Slate Processing, Section 1424: Site Development.
  - -Jeff King: Not all Select Board members have had a chance to read it yet.
  - -Warn one more time to address concerns of transparency.
    - Note in the warning that the Planning Commission recommendation is available at the Town office.
  - -Terry Williams: Which pits are actually grandfathered?
  - -Paul Donaldson: No list of active 250 quarries
  - Craig Markcrow, Vermont Structural Slate: Did the Planning Commission get a copy of the recommendations we put together?
  - Paul Donaldson: Yes.
  - Chris Smid: Make all minutes available on website.

Tom Coloutti made a motion to have a hearing, for the petition to Amend Bylaws, re: Section 417: Slate Mining, Section 418: Slate Processing, Section 1424: Site Development, on December 11, 2017, then make a decision the following Select Board meeting. Terry Williams seconded the motion. Motion carried

- -Steve Taran: Maybe move the meeting to a bigger room.
  - -possibly at the High School Library
- York Street Extension resident: Why did you give Hilltop Slate a cease and desist, if you're not going to make them stop?
- Paul Donaldson: To put him on notice. I hired an engineer to look at the road where they were blasting to see if it's been damaged.
- Stephen Benard, Rutland County Sheriff, presentation
  - -Contract increase of approximately 2.25 %
  - -Paul Donaldson: What about scheduling and continuity?
  - -Sheriff Benard: The goal is one deputy assigned here and will stagger up the patrol for time-off. The Department is having a meeting tomorrow night. We'll be discussing nine patrolmen dedicated to four towns (not to include Poultney to start).
  - -Paul Donaldson: Is James Bennick going to stay here?
  - -Sheriff Benard: I will know more after tomorrow's meeting.
  - -Terry Williams: Concerned about repeat speeding offender(s) and overweight vehicles.
  - -Sheriff Benard: Contact Kevin Geno with the Highway Safety Program, you can also call me directly.
  - Terry Williams: What is the procedure when contacting the police?
  - -Sheriff Benard: If it's an emergency, call 911. For non-emergency call the Sheriff Department. If my office doesn't have anyone who can come, we can flip it to the State Police, but I leave that up to you. If can wait, James Bennick will return your call. Again, you can always call me direct.
  - -Frank Fressie: Do we have access to data banks?
  - -Sheriff Benard: We get media updates of what other officers are doing every twelve hours. I'm also urging our guys to attend Town festivals and gatherings, if only for a short time, just to be available to people. I've been putting out weekly stats to Front Porch Forum and WVNR.
  - Also, you can get access to all officer's activity reports by logging onto, rutlandsheriff.net (I will give Paul login and password).
- Kathleen Guiness, Rutland County Volunteer Climate Coalition
  - -here to get a resolution for Town meeting
  - -gave Select Board members hand-out of the Resoultion (they read it)
  - -Paul Donaldson: If you want to put this in front of the voters, you'll need to get a 110 names.
  - -Jeff King: It's a complex issue. You'll have to be the one to speak about it.
  - Kathleen Guiness: That's fine, I'm happy to do so, it's why I'm here.

- Ryan Ihrke, Office of Sustainability, Green Mountain College, Resiliency Plan
  - -We are here about disaster preparedness, trying to mitigate risks and vulnerabilities
  - -Paul Donaldson: The Town does have an Action Plan.
  - -Ryan Ihrke: We're looking for areas we can collaborate.
  - -Terry Williams: Incident Training with Sean Galvin. I did the training about two yrs ago.
  - and make sure all your buildings on campus are up to code, maybe call the Fire Department to set up an inspection. Does the College have generators?
  - -Ryan Ihrke: No.
  - -Jeff King: You may want to call your insurance company or VOSHA, you'll find that when you're proactive, they welcome the assist.

Frank Fressie: The Senior Center may likely need help during a critical time.

# **Road Report:**

Ron Kelley reported the following:

- Work Safe Project items are all complete
- Installed a new part on the furnace (water jacket)
- Two sand and salt trucks are ready
- Trying a pretreated mixture for the first time (it's more expensive, but I want to see how it works)
  - -Tom Coloutti: What preparations are left for winter?
  - -Ron Kelley: Need to put the sanders on the back of trucks.
  - -Tom Coloutti: Is there still more grading?
  - -Ron Kelley: Yes.
  - -Tom Coloutti: When do you all go back to five days' work week?
  - -Ron Kelley: After deer season. The guys are on call. Recently replaced two pagers, so where ever they are, they'll get the page.
- Guardrails came in for Grove / South Street Bridge -the work was completed by FR Lafayette. It was a grant project through the state.

#### **Town Managers Report:**

Paul Donaldson reported the following:

- Ames Hollow Road
  - Looked into the Statue to either discontinue or move from class III to class IV
  - It looks like it's going to be easier to make it a class IV road
  - Talked to the Town attorney, Neal Vreeland. The road will need to be resurveyed (unless we already have a survey). A survey will be very expensive.
  - Tom Coloutti: Have you looked into roads given up in the past?
  - Paul Donaldson: I will contact Mike Bradley about the road. He may know of a survey. He has a lot of institutional knowledge.
  - I reached out to Josh Carvahol, have not heard back from him yet. We can only put a ford in if we change to class IV road.

 Working with Bob Williams on records request for last three years of DRB and Planning Commission minutes.

## **Transact Any Other Lawful Business:**

- Mutual aid between the Town and Village
  - Paul Donaldson: trying to come up with a solution that will appear more equitable
  - -The Village plows Town Hall, Fire House and Stonebridge
  - -The Town plows Village roads, namely South Street and Granville Street
  - discussed with Ron the possibility of contributing salt to the Village
  - give 2001 one-ton pick-up truck to Village
  - -Terry Williams: Can we equate to man hours?
  - -Ton Coloutti: Do you need the truck?
  - -Ron Kelley: No.
  - -Jeff King: Lets just give them the truck. Does the Board feel ok with this?
  - -Frank Fressie: Ask them what they think its worth.
  - Paul Donaldson: I haven't talked to the Village Board yet.

Jeff King: See what happens Thursday night.

- Jeff King: How should we handle any questions we may have, as we read over all the documents, regarding the amendments to the bylaws?
  - -Paul Donaldson: If you have any questions, you can submit them to me.

# Health Officer:

- Paul Donaldson: CB Hall called about a dog
  - -Terry Williams: received two informal complaints, dog owner has been warned twice
- Terry Williams: received three calls about a rental property
  - -water supply violation (water is coming from a brook, not a well)
  - -report of mold
  - -I told her these are violations I will give to the landlord
