Jeff King called the meeting to order. Selectmen present included: Jeff King, Frank Fressie, Terry Williams, Tom Coloutti, and George Miller. Others present included Paul A. Donaldson, Town Manager, and Ron Kelley, Road Foreman.

Road Report:

Ron Kelley reported the following:

- The crew has thanked the board for the Christmas bonuses.
- The crew has been filling potholes.
- The crew applied more cold path on Route 140 where the culverts were replaced/removed.
- Ron will ask QSI to repair the ditch on Upper Road.
- Bahn pond has gone over Hillside Road again. Paul Donaldson has left a message for the owner to stop the overflow.
- Discussion regarding further excavator prices. Ron is waiting on three prices. He has looked as a JD with rubber tracks. He called Anderson Equipment in E. Montpelier, there is a CAT with 1200-1300 hours, thinks our old machine is worth 15K. He spoke with used equipment dealer in Wrench, NH, who has one for 160K with 1k hours, with 5 year warranty. Milton CAT has a machine with 137k hours for 60K. 30"-40" cutter discussion. Tom asked what the State of Vermont uses. Ron says flail mowers. Tom asked about whether the crew would still need to rent roadside mower, Ron says yes.
